**2. Dues/Accounts:** Member agrees to pay dues initially at the current rate and thereafter at the then current rate for this class of membership, which is subject to adjustment by the Club. Dues for the current month and all other indebtedness of the preceding month are due and payable on the 1st day of the current month. Accounts not paid by the 25th day of the current month are subject to a late charge for each month that the account is delinquent. Accounts delinquent for 3 months are subject to termination at Club's option without a refund or residual value.

**4. Operations:** Member agrees to operate Club vessels on a Bareboat charter basis, pursuant to all the terms and conditions of the Club's Bareboat Charter Agreement.

**5. Hold Harmless:** All Club vessels are insured against property damage risks, except for the amount of an insurance deductible. Insurance deductibles vary from boat to boat and are printed on the charter contracts. Member agrees that in the event of damage during a charter the Member is financially responsible for paying the insurance deductible. All coverage is subject to policy conditions and limitations. Member agrees to waive right of recovery or subrogation against the Club, its staff, members and boat owners for all losses which otherwise would have been covered by such insurance.

**6. Insurance:** Club shall maintain in force insurance with respect to bodily injury and property damage liability arising out of the operation of vessels owned or chartered by Club. Such insurance shall extend to include Member as additional insured with respect to the operation of said vessels. Insurance coverage is provided as follows: Club and vessel owners provide a combined single limit of liability of one million dollars (\$1,000,000); Member and vessel owners provide an excess liability umbrella of four million dollars (\$4,000,000) at the current group policy rate of \$78.00 per membership per year which is billed to Member annually and is subject to change.

**7. Membership Transfer and/or Non-Compliance:** In the event Member is unable to utilize membership for any reason, it is agreed that the initiation fee is non-refundable. Ultimate or Passage Maker Memberships may be transferred to qualified third parties by payment of the current transfer fee, expressed as a percentage of the then-current initiation fee to the Club. Applications for transfer must be submitted to Club with the appropriate fee and receive the written approval of Club which shall not be unreasonably withheld. All other types of memberships are non-transferable.

**8. Resignation of Membership:** Resignation must be in writing and account paid current. **Initial:** \_\_\_\_\_
